Thanks to your generous hospitality gifts last summer, we

were able to purchase a new, and more versatile, outdoor grill. In addition, we bought a dishwasher specifically for the volunteers who open and close the season because every plate, glass, dish, pan, utensil, etc., is washed preand post-season. (Guests, you can still look forward to washing all your dishes by hand, the dishwasher will not be available during the season.)

Speaking of volunteers—the spring work days are June 1–4 and June 16–23. The fall work days are Aug. 26–27 and Aug. 29–Sept. 2. Come for as many or as few days as your schedule allows. ECOC costs stay low because our volunteers help to open and close our buildings and take care of routine maintenance.

Tasks range from light to more labor-intensive. A variety of skills are needed, and it is always a great time of fellowship. There is **no charge** for accommodations during the work days. If you work a minimum of 16 hours, you will receive priority consideration for reservations the following season! ECOC Covid Policy

We require proof of each guest's up-to-date vaccination status **by May 1**. The CDC website defines "up-to-date" as having "completed a Covid-19 vaccine primary series and gotten the most recent booster dose recommended for you by CDC."

- Take a picture of the front and back of the vaccination card for each guest and email it to ECOCRegistrar@gmail. com. Or photocopy it and mail it to ECOC Registrar, P.O. Box 988, Chautauqua, NY 14722.
- Guests who are 4 years old or younger are exempt.
- For medical exemptions, ECOC requires that a medical doctor's note be submitted to the ECOC Board via the Registrar by May 1.
- Religious exemptions must also be requested from the ECOC Board via the Registrar by May 1.

Wireless Upgrades

If you've been to ECOC in the past few summers, you might have used our expanded wireless network (WiFi). Thanks to the volunteer work of Kyle Doershuk and Bob Dargel, new wiring was laid out, new wireless access points installed, and a central control system was set up. This past summer, one outdoor antenna was installed on the 4th floor parapet of the Bird-Werner building as an experimental setup. While it is more difficult to install external antennas (wind, rain and snow considerations), the hope is to expand wireless access on the porches as much as possible. Also planned for this spring is upgrading a few internal access points to cover the few remaining internal areas in need of coverage. Thanks for all the feedback on how the system has been working as it allows for the design of future upgrades during the offseason!

The property committee has met over the winter to both analyze and disseminate the "2022 Bero Assessment." We consider the work to be a once-in-a-generation opportunity to secure the future of the ECOC buildings, and have broken out the assessment into phases of construction. These include:

- Early Essentials
- Building Basics and Long-Term Preservation
- Major Projects at the Westervelt

Early Essentials are projects that we hope to accomplish in the next year or two and include the possibility of the Westervelt roof replacement, as well as numerous general safety repairs. The Property Committee has examined an extensive list of recommended Chautauqua Institution general contractors to narrow and define a list of approved firms to solicit for bidding on projects.

Realizing that all future work will be steered by available funding and board approval, Jeff Kane, Development Chair, has joined with the Property Committee. Jeff offers a fresh voice and an intelligent perspective about fundraising as it will relate to the accomplishment of selected and supported projects from the ambitious "2022 Bero Assessment."
